MUNICIPAL ORDINANCE NO. 64

AN ORDINANCE CREATING THE EQUIVALENT POSITIONS
OF THE DEVOLVED DEPARTMENT OF AGRICULTURE.

WHEREAS, Republic Act 7160, hereinafter referred to as the Local Government Code of 1991 transfer the responsibility of basic services and facilities from the National Government Agencies (NGA's) concerned to the Local Government Unit;

WHEREAS, Executive Order 503, mandates the transfer of Assets and Personnel and the creation of equivalent positions of the affected personnel to the Local Government Unit concerned;

WHEREFORE, on motion of Hon. Jovencio M. Pascua, duly seconded by Hon. Ismael L. Agulay, be it

ORDAINED, by the Sangguniang Bayan of Solsona, Ilocos Norte, that:

Section 1 - The positions of the devolved Department of Agriculture are hereby created, to wit:

- a. 1 Municipal Agricultural Officer
- b. 7 Agricultural Technologists:
 1. Lydia A. dela Cruz - Crops
 2. Natividad R. Manuel - Crops
 3. Pablo Bartolome - Livestock
 4. Cesario Cong-o - Cooperative
 5. Ligaya Tomas - FYDP-RIC Coordinator
 6. Lolita Aguinaldo - Fishery
 7. (Vacant) - Nursery Manager

Section 2 - This Ordinance shall take effect after a lapse of ten (10) days from the day a copy of it is posted in a bulletin board and other conspicuous places;




