MUNICIPAL ORDINANCE NO. 66

AN ORDINANCE CREATING THE EQUIVALENT POSITIONS
FOR THE POSITION OF SOCIAL WORKER OFFICER III,
SOCIAL WORKER I AND SOCIAL WORKER AIDE.

WHEREAS, Republic Act 7160 herein after referred
to as the Local Government Code of 1991, transfers the
responsibility of basic services and facilities from the
National Government Agencies (NGA's) concerned to the LGU;

WHEREAS, Executive Order No. 503 mandates the
transfer of Assets and Personnel and the creation of equi-
valent positions of the affected personnel title LGU con-
cerned;

WHEREFORE, on motion of Hon. Jovencio M. Pascua,
duly seconded by Hon. Gervacio B. Vicente, be it

ORDAINED, by the Sangguniang Bayan of Solsona,
Ilocos Norte, that:

Section 1 - The positions of the devolved Department
of Social Welfare and Development (DSWD) are hereby created,
to wit:

- a) 1 SWO III - Vacant
- b) 1 SWO I - Mrs. Nenita A. Aquino
- c) 1 SW Aide - Vacant

Section 2 - This Ordinance shall take effect after a
lapse of ten (10) days from the day a copy of it is posted in
a bulletin board and other conspicuous places;


