MUNICIPAL ORDINANCE NO. 68

AN ORDINANCE LEVYING FEES FOR SEALING AND
LICENSING OF WEIGHTS AND MEASURES.

On motion of Hon. Rogeric E. Teodoro, duly
seconded by Hon. Ismael L. Agulay, be it

ORDAINED, by the Sangguniang Bayan of Solsona,
Ilocos Norte, that:

Section 1 - Fees for sealing and licensing of
weights and measures shall be in accordance with the
following schedule, to wit:

- a) For sealing linear metric measures:
 - a.1. measures not over one meter - ₱1.00
 - a.2. measures over one meter - 2.00
- b) For sealing metric measures of capacity:
 - b.1. measures not over ten liters - ₱1.00
 - b.2. measures over ten liters - 2.00
- c) For sealing metric instruments of weights:
 - c.a. those with a capacity of not more than 30 kilograms - ₱2.00
 - c.b. those with a capacity of more than 30 but not more than 300 kilograms - ₱3.00
 - c.c. those with a capacity of more than 300,000 kilograms - 6.00
- d) For an apothecary balance or other balance of precision, the fee shall be doubled;
- e) A complete set of weights for each scale or balance shall be sealed free of charge; For each extra weights, the fee shall be FIFTY PESOS (₱50.00);

Section 2 - The fees herein levied shall be paid at the place where the business is conducted. In the case of a peddler or similar itinerant vendor using only one weight or measure, he shall pay the fees in his place of residence;

Section 3 - The fees herein levied shall be collected by the Municipal Treasurer or her duly authorized representative;

Section 4 - Fraudulent practices and unlawful possession or use of instruments of weights and measures shall be punished by a fine of not less than ONE THOUSAND PESOS (P1,000.00) but not more than FIVE THOUSAND PESOS (P5,000.00) or by imprisonment of not less than one month but not more than six months or both at the discretion of a court;

Section 5 - This Ordinance shall take effect after the lapse of ten (10) days from the day a copy of it is posted on the bulletin board, Municipal Churches, Market and other conspicuous places;

Copies of this Ordinance be furnished the Sangguniang Panlalawigan, Laoag City, the Municipal Treasurer, Solsona, Ilocos Norte, for their information;

Voting on the foregoing measures as follows:


