MUNICIPAL ORDINANCE NO. 99

AN ORDINANCE AUTHORIZING ^{Nu} LOCAL CHIEF EXECUTIVE
MAYOR JOSEPH E. DE LARA TO EXECUTE AND SIGN
ON BEHALF OF THE MUNICIPAL GOVERNMENT THE DEEDS
OF TRANSFER OF ONE UNIT (1) OF DUMP TRUCK.

WHEREAS, pursuant to the provisions of Article
87 (b) (vi), the Sangguniang Bayan is empowered to grant
authorization to represent the Municipality in all its
business transactions and sign on its behalf all bonds,
contracts and obligations and such other documents made;

WHEREFORE, by virtue of the power vested upon
the Sangguniang Bayan and pursuant to the aforementioned
provisions of Republic Act 7160, be it ordained that;

SECTION 1 - The Local Chief Executive, Mayor
Joseph E. de Lara is hereby given the authority to execute
and sign on behalf of the Municipal Government the deeds
of transfer of ONE UNIT (1) of Dump Truck.

SECTION 2 - This Ordinance shall take effect
upon approval of this Ordinance.
