SHIRLEY C. AGRUPIS, TO PROVIDE LEARNING HUBS ACCESSIBLE TO MMSU STUDENTS FOR ONLINE ADMISSION, ENROLLMENT, ORIENTATION AND ONLINE LEARNING.**

**WHEREAS**, the emergence of COVID-19 Pandemic in the world has caused a global crisis to the entire populace imposing limitation to mobility and the need for social distancing;

**WHEREAS**, the flexible learning arrangement necessitates SUCs and HEIs to engage in collaborative efforts with Local Government Units, and other agencies to converge their resources for the delivery of quality learning alternatives;

**WHEREAS**, the Mariano Marcos State University has initiated "MMSU-LGU-TELCO Convergence for Virtual Learning Project" embodying the tripartite convergence of MMSU, Local Government Units and other agencies to ensure that no students is left behind in this "new normal";




