DE LARA TO REPRESENT ON BEHALF OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH MARIANO MARCOS MEMORIAL HOSPITAL AND MEDICAL CENTER, WITH A LOCATION AT BATAK CITY, ILOCOS NORTE, REPRESENTED BY ITS MEDICAL CENTER CHIEF, DR. MARIA LOURDES OTAYZA, TO ASSIST THE SOLSONA RURAL HEALTH UNIT (RHU) IN UPGRADING OBSTETRIC SKILLS THEREBY MAKING THE SERVICE ACCESSIBLE TO PATIENTS SEEN AT THE SOLSONA RHU ONCE A WEEK.

WHEREAS, the Mariano Marcos Memorial Hospital and Medical Center has an accredited training program by the Philippine Obstetrical and Gynecological Society Inc., that can ensure skill and quality of services of OB-GYN resident physicals of the hospital;

WHEREAS, the Mariano Marcos Memorial Hospital and Medical Center OB-GYN is cultivating an involvement by assisting the Rural Health Units to upgrade their obstetric skills, thereby making the service accessible to patients seen at the Rural Health Unit once a week;

NOW THEREFORE, on motion of Hon. Norberto L. Agulay, unanimously seconded by all members present, it was;




