WHEREAS, the Cybercrime Prevention Act of 2012, officially recorded as Republic Act No. 10175, is a law in the Philippines approved on 12 September 2012 which aims to address legal issues concerning online interactions and the internet in the Philippines among the cybercrime offenses:

WHEREAS, there are some dummy accounts that are jeopardizing some members of the Sangguniang Bayan, the Vice Mayor and the clerks of the Office of the Sangguniang Bayan through malicious messages on the social media particularly in Facebook;

WHEREAS, Jhonson Smith, Bagas Rupam and Sheena Liang are dummy accounts who are posting offensive and harassing messages, dissing someone or spreading nasty rumors and disclosing intimate personal information against the Office of the Sangguniang Bayan;

NOW THEREFORE, on motion of Hon. Mark Dennis P. Del Castillo, duly seconded by Hon. Cesar Paul M. Parado, it was;

RESOLVED AS IT HEREBY RESOLVED to REQUEST THE NATIONAL BUREAU OF INVESTIGATION (NBI) CYBER CRIME DIVISION TO INVESTIGATE THE PERSONALITIES OF JOHNSON SMITH, BAGAS RUPAM AND SHEENA LIANG;


RESOLVED FINALLY to transcribe copies of this Resolution to be furnished the National Bureau of Investigation, Laoag City for their information and appropriate action;
