DE LARA TO REPRESENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT-FIELD OFFICE 1, REPRESENTED BY ITS REGIONAL DIRECTOR MARCELO NICOMEDES J. CASTILLO, WITH PRINCIPAL OFFICE AT QUEZON AVENUE, SAN FERNANDO CITY, LA UNION, TO IMPLEMENT MICROENTERPRISE DEVELOPMENT PROJECTS FOR SUSTAINABLE LIVELIHOOD PROGRAM (SLP) BENEFICIARIES THAT WILL ENABLE THEM TO ACTIVELY PARTICIPATE IN THE LOCAL ECONOMY AS COOP-ENTREPRENEURS.**

**WHEREAS**, the Department of Social Welfare and Development as the lead agency in social protection, welfare and development, contributes poverty alleviation and empowerment of the disadvantaged through the provision of appropriate interventions and the promotion of the rights and welfare of the disadvantaged through local and national policies, programs, projects and services implemented with and/or through local government units, people's organizations and other government organizations and other members of the society ;

**WHEREAS**, it has continuously implemented poverty reduction programs such as the Sustainable Livelihood Program (SLP) which is mainly a community-based capacity building program that involves a two-track system in which participants are given two option to take either the (a) Micro-enterprise development track or (b) employment facilitation track after participating in social preparation and capacity-building activities to be conducted by the project development officers from different regions ;

**WHEREAS**, the Local Government Unit of Solsona, Ilocos Norte agrees to cooperate, collaborate and jointly implement microenterprise development projects in the Municipality for SLP beneficiaries that will enable the beneficiaries to actively participate in the local economy as coop-entrepreneurs;


