RESOLUTION NO. 2020-093

GRANTING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E. DE LARA, TO FULLY IMPLEMENT THE ENHANCED COMMUNITY QUARANTINE AND OTHER RELATED ISSUANCES OF THE PRESIDENT OF THE PHILIPPINES, RODRIGO ROA DUTERTE AND THE PROVINCIAL GOVERNOR, J. MATTHEW MARCOS MANOTOC.

WHEREAS, Section 16 of the Local Government Code provides that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, COVID-19 has brought extensive alarm and concern not only to the Municipality of Solsona, Ilocos Norte but to the whole world due to the pandemic brought about by the dreadful COVID-19 of which its transmission is so loose, that even the developed countries are now suffering from chaos, fear and panic, and worst causing death to those infected with the anxious virus;

WHEREAS, President Rodrigo Roa Duterte declared a state of calamity throughout the Philippines due to corona virus disease 2019;

WHEREAS, consonant to such directive from Malacañang Palace, the Governor of the Province of Ilocos Norte Hon. J. Matthew Marcos Manotoc issued Executive Order 60-20 series of 2020 placing the Province of Ilocos Norte under "community quarantine" to prevent the possible spread of COVID-19 in the locality;

WHEREAS, the Municipality of Solsona, Ilocos Norte has been taking necessary measures to prevent the possible spread of the pandemic;

NOW THEREFORE, on motion of Hon. Benigno L. Aquino, unanimously seconded by all the members present, it was;


