GRANTING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E. DE LARA, TO REPRESENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT REGIONAL OFFICE 1 (DOLE RO1) A GOVERNMENT OFFICE EXISTING BY VIRTUE OF THE LAWS OF THE REPUBLIC OF THE PHILIPPINES WITH PRINCIPAL OFFICE ADDRESS AT MABINI ST., CATBANGEN, SAN FERNANDO CITY, LA UNION, REPRESENTED HEREIN BY ITS REGIONAL DIRECTOR, NATHANIEL V. LACAMBRA TO IMPLEMENT THE TULONG PANGHANAPBUHAY SA ATING DISPLACED/DISADVANTAGED (TUPAD) WORKERS PROGRAM TO ENABLE THE DISPLACED WORKERS, UNDEREMPLOYED AND SEASONAL WORKERS TO ENGAGE IN SHORT-TERM COMMUNITY WORKS TO PROVIDE THEM WITH TEMPORARY WAGE EMPLOYMENT FOR A PERIOD OF TEN (10) DAYS.

WHEREAS, it is the National Government's policy to implement poverty alleviation project in all regions and the Department of Labor and Employment (DOLE) is mandated to promote gainful employment opportunities, develop human resources, protect workers and promote their welfare, and maintain industrial peace;

WHEREAS, the DOLE provides assistance to help displaced or "to be" displaced workers in coping with the closure or slowing down of operations of companies as a result of economic disruptions and/or the occurrence of natural disasters, calamities, or armed conflicts that affect their economic base and to augment the meager income of the underemployed and seasonal workers under its **TULONG PANGHANAPBUHAY SA ATING DISPLACED/DISADVANTAGED (TUPAD) WORKERS PROGRAM**, pursuant to the provisions of DO No. 173, series of 2017;

WHEREAS, the **DOLE-RO No. I** has been given the responsibility to implement the TUPAD Program to enable the displaced workers, underemployed and seasonal workers to engage in short-term community works to provide them with temporary wage employment for a period of ten (10) days;

WHEREAS, the Sangguniang Bayan deemed it proper that the said program shall be implemented with the provision that such program will be equally divided to the twenty-two (22) barangays of the Municipality of Solsona, Ilocos Norte;

WHEREAS, this partnership is vital to ensure the successful implementation of the said projects and achieve their desired social outcomes;

NOW THEREFORE, on motion of Hon. Benigno L. Aquino, duly seconded by Hon. Jonathan L. de Lara and Hon. Reynaldo G. Mariano, it was;

RESOLVED, as it is **HEREBY RESOLVED** to **GRANT AUTHORITY TO THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E.
