DE LARA, TO REPRESENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SOLSONA, ILOCOS NORTE TO ENTER INTO A CONTRACT (DEED OF DONATION AND ACCEPTANCE) WITH THE OKADA FOUNDATION, INC. WITH PRINCIPAL OFFICE ADDRESS AT OKADA MANILA, NEW SEASIDE DRIVE, ENTERTAINMENT CITY, PARANAQUE CITY, REPRESENTED BY MR. KENJI SUGIYAMA IN CONNECTION WITH THE FIGHT AGAINST COVID-19 IN THE FORM OF FOOD/GROCERY ITEMS WITH TOTAL VALUE OF APPROXIMATELY FOUR HUNDRED FIFTY THOUSAND PESOS (P450,000.00).

WHEREAS, the declaration of community quarantine and the imposition of Stringent Social Distancing measures affected the population's mobility as ingress and egress to and from the Province/City/Municipality have been restricted, causing the struggle of Filipino families for economic survival;

WHEREAS, the OKADA Foundation, Inc., in connection with the fight against COVID 19, identified the Municipality of Solsona, Ilocos Norte as one of the recipients of the P450,000.00 worth of food/grocery items;

WHEREAS, the Municipality of Solsona, Ilocos Norte agrees to collaborate, cooperate and jointly implement for the distribution of these goods as relief assistance to the constituents of the municipality;
