DE LARA, TO REPRESENT ON BEHALF OF THE MUNICIPAL GOVERNMENT OF SOLSONA, ILOCOS NORTE TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PROVINCIAL GOVERNMENT OF ILOCOS NORTE WITH OFFICE ADDRESS AT J.P. RIZAL STREET, BRGY. 10, LAOAG CITY REPRESENTED BY GOVERNOR, HON. MATTHEW J. MARCOS MANOTOC AND TO ANY STRANDED PERSON WHO RETURNS TO THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE FOR THEIR ENTRY TO THE MUNICIPALITY FROM THE PROVINCIAL BORDERS.**

**WHEREAS**, on March 29, 2020, the Province of Ilocos Norte was placed under a total lockdown through Executive Order No. 65-20 due to Corona Virus Infectious Disease 2019, disallowing the entry of people and non-essential cargoes in the province;

**WHEREAS**, there are some people stranded at the boarders who claim to be residents of the Municipality of Solsona, Ilocos Norte;

**WHEREAS**, the Municipality of Solsona, Ilocos Norte agrees to cooperate with the Provincial Government for the entry of residents of the Municipality of Solsona, Ilocos Norte who are stranded at the Provincial borders;

**NOW THEREFORE**, on motion of Hon. Benigno L. Aquino, unanimously seconded, it was;
