RESOLUTION NO. 2020-103

GRANTING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E. DE LARA TO GRANT GRACE PERIOD TO TAX PAYERS SIXTY (60) DAYS AFTER THE LIFTING OF THE ENHANCED COMMUNITY QUARANTINE.

WHEREAS, Section 250, 2nd paragraph of RA 7160, otherwise known as the Local Government Code of 1991 state that "the date for the payment of any other tax imposed under this title without interest shall be prescribed by the Sanggunian concerned;

WHEREAS, the 2017 Revised Revenue Code of the Municipality of Solsona, Ilocos Norte, provides for the Payment of taxes, fees and charges;

WHEREAS, on March 16, 2020, President Rodrigo Roa Duterte issued Proclamation No. 929 declaring the Republic of the Philippines under State of Calamity by reason of COVID-19 and in line with this proclamation, declared the entire Luzon are under "Enhanced Community Quarantine"

WHEREAS, as a result of which, the people are not allowed to go out to pay their respective taxes, thus, the urgent need to extend the day for the payment of said taxes, fees and charges;

WHEREAS, in solidarity to the worldwide action and campaigns in combating and coping with this COVID-19 pandemic, the Municipal Government of Solsona, Ilocos Norte will give grace period to tax payers of the municipality sixty days after the Enhance Community Quarantine will be lifted.

RESOLVED, as it is hereby **RESOLVED** to **GRANT AUTHORITY TO THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E. DE LARA TO GRANT GRACE PERIOD TO BUSINESS TAX PAYERS SIXTY (60) DAYS AFTER THE LIFTING OF THE ENHANCED COMMUNITY QUARANTINE.**
