REQUESTING HON. WENDEL E. AVISADO, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO ALLOCATE FUNDS IN THE AMOUNT OF TWO HUNDRED FIFTY-FOUR MILLION ONE THOUSAND SEVEN HUNDRED NINETY-FIVE AND 13/100 PESOS (P 254,001,795.13) FOR THE PROJECT TITLED "RIVER EMBANKMENT WITH MASONRY SLOPE PROTECTION" LOCATED AT CORA RIVER, BARANGAY SANTIAGO, SOLSONA, ILOCOS NORTE.

WHEREAS, Section 17 of Republic Act 7160 otherwise known as the Local Government Code of 1991 mandates the provision of basic services and facilities to the people;

WHEREAS, the Municipality of Solsona, Ilocos Norte is very much concerned on the devastating effects of flooding in our area of jurisdiction;

WHEREAS, there is a need to address the above-mentioned problem and adopt measures that will prevent flooding problems in our municipality and one of the effective measures in the prevention of flood is the establishment of river embankment;
