REQUESTING HON. WENDEL E. AVISADO, SECRETARY, DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) TO ALLOCATE FUNDS IN THE AMOUNT OF NINETY-FIVE MILLION SEVEN HUNDRED NINETY-FIVE THOUSAND SEVEN HUNDRED THIRTEEN AND 33/100 PESOS (P 95,795,713.33) FOR THE PROJECT TITLED "RIVER EMBANKMENT WITH MASONRY SLOPE PROTECTION & PCCP" LOCATED AT BARANGAYS LAURETA AND JUAN, SOLSONA, ILOCOS NORTE.

WHEREAS, Section 17 of Republic Act 7160 otherwise known as the Local Government Code of 1991 mandates the provision of basic services and facilities to the people;

WHEREAS, the Municipality of Solsona, Ilocos Norte is very much concerned on the devastating effects of flooding in our area of jurisdiction;
