ANA, SOLSONA, ILOCOS NORTE DULY REPRESENTED BY THE IRRIGATOR'S ASSOCIATION PRESIDENT, MR. ROGELIO DEL CASTILLO, HEREIN REFERRED TO AS "RECIPIENT", FOR THE PROVISION OF PRODUCTION SUPPORT SERVICES AND ASSISTANCE TO FARMER'S ASSOCIATIONS/ORGANIZATIONS AND OTHER STAKEHOLDERS.


