RESOLUTION NO. 2020-289

GRANTING AUTHORITY TO THE LOCAL CHIEF EXECUTIVE, HON. JOSEPH E. DE LARA TO REPRESENT ON BEHALF OF THE MUNICIPALITY OF SOLSONA, ILOCOS NORTE TO ENTER INTO A COLLECTIVE NEGOTIATION AGREEMENT (CNA) WITH THE UNITED GOVERNMENT SERVANTS ASSOCIATION (UGSA) INC. WITH PRINCIPAL OFFICE LOCATED AT SOLSONA, ILOCOS NORTE DULY REPRESENTED BY PRESIDENT, MR. JOHN REY LOYOLA.

WHEREAS, the 1987 Philippine Constitution granted to the government workers the right to form unions/associations and collective negotiations through the following:

1. *Article IX, Section 2 (5). "The right to self-organization shall not be denied to government employees."*
2. *Article III, Section 8. "The right of the people, including those employed in the public and private sectors to form unions, associations or societies for purpose not contrary to law shall not be abridged."*

WHEREAS, Chapter 6, Title I, Book V of Executive Order No. 292 (Administrative Code of 1987 dated 25 July 1987), authorizes all employees of the government including those in GOCC's with original charters, to form, join or assist employees' organizations of their own choosing for furtherance and protection of their interests;

WHEREAS, the Municipality of Solsona, Ilocos Norte recognizes and supports the rights of employees to self-organization and to collective negotiations on terms and conditions of employment;

WHEREAS, the UNITED GOVERNMENT SERVANTS ASSOCIATION (UGSA) INC. is recognized as the sole and exclusive representative of all rank and file employees of the Municipality of Solsona ;

WHEREAS, the UNITED GOVERNMENT SERVANTS ASSOCIATION (UGSA) INC. and the Municipality of Solsona, Ilocos Norte have mutually agreed to establish a working environment which will promote harmonious relationship between them and enhance the employees' welfare and productive contribution to the attainment of an improved, effective and efficient delivery of public service;

NOW THEREFORE, on motion of Hon. Benigno L. Aquino, unanimously seconded by the members present, it was;


